CERTIFICATE OF INSURANCE

TO WHOM IT MAY CONCERN

THIS IS TO CERTIFY that as Insurance Brokers we have placed Insurance in the name of JETBEE GROUP SE And/or affiliated, associated, inter-related subsidiary or controlled company, as now or hereinafter constituted (hereinafter referred to as the "Insured") covering their operations in connection with their fleet of aircraft, including all new and acquired aircraft from the moment they become the insurance responsibility of the Insured, whilst operating anywhere in the World but excluding Algeria, Burundi, Far North Region of Cameroon, Central African Republic, Democratic Republic of Congo, Ethiopia, Kenya, Mali, Mauritania, Nigeria, Somalia, The Republic of Sudan, South Sudan, Colombia, Peru, Afghanistan, Jammu & Kashmir, North Korea, Pakistan, Abkhazia, Ukraine (including Crimea, Donetsk & Lugansk regions), Nagorno-Karabakh, North Caucasian Federal District, South Ossetia, Belarus, Russia, Iran, Iraq, Lebanon, Libya, North Sinai Province of Egypt (including Taba International Airport), Syria, Yemen and any country where the operation of the insured Aircraft is in breach of United Nations sanctions. However, coverage is granted for the over flight of any excluded country where the flight is within an internationally recognised air corridor and is performed in accordance with International Civil Aviation Organisation recommendations) but always excluding overflying Belarus, Federation of Russia, Ukraine; or in circumstances where an insured Aircraft has landed in an excluded country as a direct consequence and exclusively as a result of force majeure, against the following risks and up to the limits stated:-

1. HULL ALL RISKS of loss or damage to the aircraft whilst flying, taxiing, ingestion or on the ground for the Agreed Value. The coverage provided under this insurance is subject to the following deductibles:-

EUR 20,000 each loss excluding in the event of Total Loss or Constructive Total Loss or Arranged Total Loss and excluding War, Hi-jacking and Other Perils according to AVN48B Clause.
2. HULL WAR AND ALLIED RISKS as excluded by the War Hi-jacking and Other Perils Exclusion Clause (AVN 48B) other than paragraph (b) thereof (wording based on LSW 555D), for an agreed value as at (1) above. The coverage provided under this insurance excludes confiscation by the Government of country of Aircraft Registry.
3. LIABILITIES
 - 3.1 AIRCRAFT THIRD PARTY, PASSENGER, BAGGAGE, CARGO and MAIL LEGAL LIABILITY for a Combined Single Limit (Bodily Injury/Property Damage) of EUR 50,000,000 any one Occurrence, each aircraft.

SDR 250,000 per passenger for death or bodily injury.

SDR 6,303 for delay in carriage of passengers arising from an insured occurrence, damages otherwise arising are self-insured by the above-mentioned airline/operator.

SDR 1,519 for damage to baggage and delay in carriage of baggage from an insured occurrence, damages otherwise arising are self-insured by the above-mentioned airline/operator.

SDR 26 per kilogram for damage to cargo and mail

It is further certified that Insurers have applied the Date Recognition Exclusion Clause - AVN 2000A and have agreed to provide limited "writeback" of coverage in respect thereof in accordance with the Date Recognition Limited Coverage Clauses AVN 2001A and AVN 2002A, as applicable.

Subject to the terms, conditions, aggregate extension clause(s), limitations, exclusions and cancellation provisions of the relative contract number(s), as held on file by Howden Specialty, effective for the period from 13 July 2026 to 12 July 2027, both days inclusive, Local Standard Time.
